Based on our four themes of internal control, human resource management, environmental management and social contribution, we will implement activities in a wide range of areas and build a trustworthy relationship with all stakeholders.

#### **Corporate Governance**

The company actively carries out the "compliance and risk management promotion activities" to strengthen the internal control function, to strengthen the oversight function of the board of directors and the oversight function of the headquarter and the internal audit & secretarial office to establish the transparent corporate control system having social trust.

The goal of corporate governance is to ensure all the management and staff correctively implement business operation in accordance with the statutes and realize internal and external supervising operation management. It is to say maintaining the management system in the state of effectively running. Currently the company has a management system represented by quality, environment, health and safety. All management departments not only the direct departments, but the indirect departments also run PDCA by this management system and gradually improve the business.

#### Compliance



The company requires the full implementation of compliance activities, and in order to achieve the objective of the compliance promotion, we set the Compliance Promotion Committee, composed by the chairman, vice chairmen and members, compliance promotion responsible person and the secretariat. Since June 2007, we convene a meeting of the Compliance Promotion Committee once every six months to conduct compliance promotion activities. The Promotion Committee's duties are: to determine compliance development direction throughout the company; to implement compliance activity reports and evaluation; to control the violation matters of compliance; to carry out elementary education and other compliance related matters.

In addition, we set the Compliance Oversight Committee whose duties are to deal with the problems in the process of compliance promotion.

#### ■ Compliance policy

Our business activities comply with domestic and international laws, corporate ethics and the criteria of the related parties. All participate in continuous improvement and establish the trust of the community, continue to work with customers to create new values and contribute to the sustainable development of society.

#### ■ Compliance reporting system

If an employee finds corrupt or non-compliance behaviors, he should directly feedback to the Compliance Report suggestion box. We also publish and open the report channel of the Compliance Oversight Committee to suppliers and related parties.



Taking into account of the rapid changing operating environment, the risk issues which will bring serious impact to business activities or harm to the corporate value may increase. To this end, we hold a meeting of the Risk Management Promotion Committee with the goal of developing the business sustainably and improving the interests of our company. Since October 2009, every three months to every six months, the ministers over management staff participate in a regular meeting of risk management. In order to further promote the risk management activities, the various departments seriously discuss what measures should be taken and what specific should be done around the company's risks. All departments develop and implement a program of activities. Through risk management activities, staff optimization, environmental improvement and cost improvement get good results. We have established and improved the company's risk management activities institutional.

#### Safety and health activities

#### Safety, Health and Environment Committee

The general manager serves as the chairman, and convenes monthly meeting regularly, the staff above the section manager of management department level and the staff above the team manager of production sector and staff representatives attend the meeting as members of the Committee, listen to the security environment department reporting security environment indicators advancing results of that month, discuss security environment priorities. It is the highest-level meeting of security environment management.

0 work-related injuries, 0 occupational diseases are the company's annual production safety goals. In order to achieve these goals, doing well the three-level safety education before the employees going into the factory, doing the periodic workplace environment detection, carrying out the full participation emergency drill are the focuses of the day-to-day work. From training and improving staff awareness of production safety, carry out a series of colorful safety activities, integrate the construction of safety culture into the corporate culture construction, nurture and create an overall safety culture.

In March 2011, we achieved the Beijing Municipal Safety Month Activities Award of Excellence. In October 2011, we were awarded the Beijing "The safety songs sung Event" Award of Excellence, in November 2011, we achieved the Beijing Safety Month Award for best practice activities.

On the basis of the previous achievements, the company develops the 2012 annual occupational health and safety objectives and targets:

- 1. 0 injuries and occupational diseases
- 2. Less than 2 pieces of million labor hours adventure events
- 3. Sickness absence rate (cumulative) below 0.5

The following are parts of the company's safety and health activities: organize fire drills, songs of life we sing together and safety blackboard appraisal and Chinese health lectures, primary knowledge of first aid training, AIDS intervention activities and so on.













## **Environmental Management**



#### **Energy conservation activities**

Energy conservation is the eternal theme of today's society, enterprises as the mainstay of the social composition shoulder important mission of energy conservation. Advocating green and pursuing environmental protection have always been IBIDEN Group's philosophy. Since the establishment of the plant, it began to actively promote the concept of energy saving, regarding energy-saving, water-saving, natural gas-saving and reducing carbon emissions as major propulsions and got the praise of the leaders at all levels in Beijing and the Development Zone.

In October 2011, the company held the energy-saving activities kick-off meeting with the theme of "I act for energy-saving, new low-carbon life" to mobilize all employees to actively participate in energy-saving activities. The company carried out a series of energy-saving activities, including energy saving poster, energy-saving knowledge quiz, energy saving and improving the experiencing, energy saving self-praise activity and so on. Through these energy saving activities, we improve the full awareness of energy conservation, strengthen the energy conservation management and reduce the energy consumption.

In December 2011, factory one again successfully introduced reclaimed water technology after factory two first used reclaimed water in the enterprise in the development zone. As the first company which took lead in introducing reclaimed water into production in Beijing Economic and Technological Development Zone, the company became an excellent example of the development zone and got live interviewed and praised by the Development Zone television station.


In 2011, through the continuous efforts of everyone, we have achieved good results in energy-saving. In total energy use: water, electricity, gas, respectively year-on-year reduced by 15%, 8%, and 15%; in energy use amount of board area units: water, electricity, gas, respectively year-on-year reduced by 11%, 4%, and 11%.

Reducing fixed costs by way of improving the methods helps the plant meet the minimum consumption operation. Controlling variable expenses by improving management and constantly improves the rate of qualified products, and make it proportional to the production amount.

From the construction of the plants, the company formulates energy reduction targets every year, continuing to promote energy conservation improvement. 2012 annual corporate energy use unit quantity indicators: The first half of the year indicators: reducing 1.5% of the monthly unit dosage than 2011; The second half of the year indicators: reduce 3% in unit dosage than 2011 per month.









#### [Improvement of water saving]



- Import water project in Factory One, save a large amount of tap water.
- Pure water tower inverse washing water recycle, reduce tap water use.
- Recycle production line steam and air conditioning steam condensate, reduce tap water.
- Use reclaimed water to flush bathroom, substantially reduce the amount of water use.



#### [Energy-saving improvements]



- Comprehensive replace the LED lamps, reduce lighting electricity consumption.
- Introduce production equipment energy-saving mode, reduce electricity consumption in the production process.
- Improve temperature control, reducing the electricity consumption of the air conditioning system in the public areas.
- Introduce inverter, reducing the waste of electricity caused by pump frequency operation.

#### [Natural gas improvement]



- Implement on-site air conditioning temperature management, reduce the air conditioning load and reduce natural gas usage of the freezer.
- Import freezer winter energy-saving mode, effectively use the outdoor cold source of cooling water in workshop, reducing the gas consumption of the freezer.
- Import new fan spring and autumn energy-saving mode, use the outdoor air-conditioning to reduce the indoor temperature, reducing the use of natural gas of the freezer.
- Recycle the production line steam and air conditioning steam condensate directly to the boilers, reducing the use of natural gas of the boilers.

## **Environmental Management**

## Focus on improving the project "new air damper reducing and improving of Plant Two"

The second plant uses the new wind system, all new wind no matter heating or humidifying in winter or cooling or dehumidifying in summer are converted using primary energy natural gas and secondary energy electricity to ensure the constant temperature and humidity in the workshops and meet the production process requirements; After field inspection and measurement, we find that there are many places on the ceiling of the factory workshops are not tightly sealed, the seals on the doors and windows in the factory aging and deforming, resulting in the loss of fresh air, causing part of the energy wasted.

After plugging and improving all air leakages at the workshop, the new air damper amount reduce 48000m3 / h on the basis of the existing wind amount. According to the amount of wind, we can turn off 1 set of small new fan, which can also correspondingly reduce the electricity and natural gas energy consumption and equipment maintenance costs. Calculate according to the amount of energy use of the previous year, we can save 1.06 million Yuan a year.







#### Implementation of green procurement

Since establishing green procurement management system in February 2011, the company strengthens the management of the supply chain. First, we convened the suppliers to hold IBIDEN Group Green Procurement Guidelines description conference in May 2011, describing for the suppliers the relative requirements of IBIDEN for implementing green procurement. Secondly, we issued questionnaires to the suppliers, requiring them to share and self-declare the harmful substance information in purchased goods. Thirdly, we examined and evaluated the suppliers, for the products containing restricted substances we will prohibit from buying, gradually reduce the amount of use of the purchased products containing the substance of management and seek alternatives. Make sure that the purchased products supplied by the suppliers meet RoHS requirements.

In the running of the green procurement management system, the Beijing factory imports harmful chemical substances management software platform, improving the level of job management and operational efficiency. At the same time, gradually establish and perfect the system files to provide protection for the good functioning of the system.









(1) CO2 emission in 2008-2011




